2009 Rules for the La Grange Farmers Market

1. The market is a Farmers Market. Sales will be primarily farm and garden products, bakery and prepared food items will be allowed. The sale of eggs is also allowed with copies of the appropriate permit(s). The sale of meat products will *not* be allowed.
2. Vendors are responsible for compliance with all requirements of the State of Texas and the City of La Grange.
3. Vendors will bring their own tables, canopies, and display racks.
4. All items for sale will be marked as such with clear pricing.
5. Vendors will display their products in a clean and safe manner
6. At the close of the market, Vendors will clean their immediate area and remove all boxes, packing materials, and trash.
7. Vendors should operate their business in a professional manner at all times.
8. Reselling is allowed.
9. Spaces on set-up day are on a first-come, first-served basis.
10. The Market Manager has the right to amend any and all rules without notice.
